INNOVATIVE CREDIT SOLUTIONS BIS End-User Agreement

This Customer Agreement is executed as of the date set forth below by the undersigned customer (hereinafter referred to as "Customer") for the benefit of Innovative Credit Solutions (hereinafter referred to as "Reseller") and Experian Information Solutions, Inc., acting through its Business Information Solutions Group (hereinafter referred to as "Experian").

A. Restrictions on Use. In consideration for Customer's right to receive and use certain data and services (collectively, the "Services") from Reseller and Experian, Customer understands and certifies to Experian and Reseller that the Services:
